Lili is the founder and driving force behind
Street Racing Kills (SRK), a non-profit
established in 2014 dedicated to combating
the dangers of street racing and reckless
driving. Through nationwide outreach,
educational programs, and advocacy efforts,
SRK has made a significant impact, with
thousands of young drivers benefiting from
safety courses. Lili, whose daughter Valentina
was killed in a street racing crash and
inspires her mission, has not only raised
awareness but also played a pivotal role in
the passage of California Assembly Bill 3, set
to take effect in 2025, increasing penalties
for street racing.



#### Raul Contreras Jr.

Raul Contreras Jr. entered prison at 18 following a regrettable incident on September 10, 1999. A heated argument with his pregnant girlfriend led to a tragic turn of events when, in an attempt to reason with her, he followed her and her friends. The situation escalated as her friend lost control of the car during unsafe driving, resulting in a fatal crash. Raul served 22 years for his involvement, emphasizing the profound impact of a single bad decision.
