MEETING NOTES – FEBRUARY 12, 2024

Welcome and Member Sharing

Melissa Valido, Florida Teen Safe Driving Coalition (FTSDC), welcomed attendees and thanked them for their participation. She provided an overview of the coalition's mission and focus area goals, which include:

- Membership
- **Outreach and Education**
- Advocacy and Public Policy

She provided background on each goal and discussed the coalition's aims for each. She asked participants to introduce themselves before reviewing the meeting agenda.

FTSDC Updates and Housekeeping

Melissa provided general updates and housekeeping reminders relevant to the FTSDC.

Flip Charts

Melissa directed attendees' attention to the flip charts set up around the room. She asked attendees to take opportunities throughout the meeting during breaks, subcommittee breakout times, or after the meeting to provide responses to the questions on the flip charts. She noted that they can be useful for planning meetings in the future.

Membership List

Melisa said that Shaina Finkel, FTSDC, was passing out a list that determined whether attendees needed to formally register to become a member of the Coalition. She also indicated that many attendees and registered members would need to fill out biographical information and be photographed over the course of the meeting for the purposes of updating the members page of the FTSDC Website.

FDOT Highway Safety Plan (HSP) Survey

Melissa said that as part of the Florida Department of Transportation (FDOT) Highway Safety Plan (HSP), the State Safety Office is conducting a survey as part of the Plan's public engagement efforts. Chris Craig, FDOT, provided background on the intent and purpose of the survey. He encouraged attendees to share the survey through their networks as well.

NHTSA Teen Driver Assessment

Melissa discussed the possibility of undergoing a National Highway Traffic Safety Administration (NHTSA) teen driver program assessment. She said that unlike other coalitions, the teen driver program is not required to regularly be assessed by NHTSA. She discussed the pros and cons of the assessment process. She said the benefits of an assessment would include insights on coalition activities, what can be improved, as well as validation of existing efforts. An assessment conducted next fiscal year could help inform the FTSDC Strategic Action Plan update the following fiscal year. The assessment process does require a significant time and effort commitment from those participating. The coalition voted to move forward in participating in an assessment. Melissa noted that other teen driver program assessments conducted by other states will be used as reference points.

Parent/Teen Folder Mailing (FLHSMV MOU)

Melissa gave an update on the Safe Driving Guide for newly licensed teens. She said that 208,910 folders have been distributed in Fiscal Year (FY) 2022-23. She said the coalition's goal is to ship Safe Driving Guides to the families of all newly licensed teens. The coalition is targeting mailing 265,000 Safe Driving Guides in FY 2023-24. She noted that this is a legacy piece of content that was developed in collaboration with AAA. This fiscal year the team intends to







meet or exceed the number of folders distributed last fiscal year. Melissa noted that there has been a change in the contracting timeframe that is anticipated to lessen distribution delays for future fiscal years despite elongating it the timeline at first. Additionally, the Florida Department of Highway Safety and Motor Vehicles (FLHSMV) is sending data on newly licensed teens quarterly. She emphasized that approximately 60 percent of the coalition's grant goes towards this endeavor. The target audience is teens who possess a learner license, aged 15-17.

New Printed Materials

Melissa provided updates on new printed materials for education and outreach. She said that the safety belt card has been approved by both the Florida Occupant Protection Coalition (FOPC) and FDOT Communications, and is moving to the printing stage. The submerged vehicle materials are awaiting approval from FDOT after incorporating feedback provided by the Palm Beach County Drowning Coalition. The Parent and Teen Safe Driving Contract as a stand-alone material, in addition to the Safe Driving guide, has been approved, and is moving to the printing stage. Melissa said that other printed materials focused on street racing, navigating railroad crossings, and avoiding drowsy driving are up next. She noted that the FTSDC is partnering with the FOPC for a golf cart precautions printed material. Additionally, she said that there are 25 table runners that are available for coalition members.

Week of Awareness Presentations – Updates and Upcoming Tour Information

Melissa provided an update on the yearly Weeks of Awareness Campaign. She said that in FY 2022-23 the campaign was conducted in 53 schools reaching 28,528 students. Each year the campaign prioritizes presentations by traffic safety speakers in priority counties within FDOT's Highway Safety Matrix for fatalities and serious injuries involving teens. She discussed the FY 2023-24 Weeks of Awareness focus counties. She said the goal is to have 80 presentations, noting this would be the greatest number of Weeks of Awareness presentations ever. She said the following areas were prioritized, noting the number of schools in each area, and provided updates on the planning process for each:

- Miami-Dade: 20 schools
 - Week 1: February 26 March 1, 2024 Jacy Good and Steve Johnson
 - Week 2: March 11-15, 2024 Kevin Brooks
- Orange: 20 schools Complete
 - Week 1: November 6-10, 2023 Kevin Brooks
 - Week 2: November 13-17, 2023 Kevin Brooks
- Palm Beach County: 10 schools
 - April 15-19, 2024 Kevin Brooks
- Hillsborough, Pasco, and Pinellas: 10 schools
 - March 18-22, 2024 Lilly Trujillo Pucket
- Broward: 10 Schools
 - March 4-8, 2024 Jacy Good and Steve Johnson
- Leon, Gadsden, Wakulla: 10 schools
 - April 22-26, 2024 Bill Cordes

Melissa said that even though Leon, Gadsden, and Wakulla counties are not priority counties based off of the Highway Safety Matrix, the Weeks of Awareness tour with Bill Cordes is being funded through State Farm and noted that State Farm specifically wanted to engage students in the Leon, Gadsden, and Wakulla areas. She emphasized the challenge of booking a 10-school tour in relatively smaller areas.







Participants had the following questions and comments:

- Rachel Silber, Hollywood Hills High School, asked what schools are scheduled for Broward County?
 - Melissa said the following high schools in Broward County have been scheduled:
 - Monarch High School
 - Miramar High School
 - Fort Lauderdale High School
 - **Coral Springs Charter School**
 - Cooper City High School
 - Are there any schools slated for presentations in Alachua County?
 - Alachua County is not in the top 40 percent of counties based on the number of fatalities and serious injuries involving teen drivers.

2023 FTSDC Teen Fact Sheet

Melissa discussed the annual Teen Fact Sheet. She provided an overview of the content within the fact sheet. She said the 2024 fact sheet should be ready to present to the coalition at the next meeting on June 27-28, 2024. The 2023 fact sheet can be found at Florida Teen Driver Fact Sheet - 2023.

NTSB - National Hispanic Youth Listening Sessions (Florida Opportunity)

Melissa provided a recap of the National Hispanic Youth Listening Session on Roadway Safety that occurred from December 11-15, 2023. She said the listening session was a partnership between the National Traffic Safety Board (NTSB), FTSDC, and the Family, Career, and Community Leaders of America (FFCLA). Six Florida teens participated in the listening sessions focused on their involvement in driver education. Melissa praised the assistance given by the Miami-Dade County School Board, Safe Kids Florida, Hollywood Hills High School, and the FTSDC Ambassador Board in identifying and participating in this opportunity. The listening session can be viewed at NTSB National Youth Listening Session on Roadway Safety: Amplifying the Voices of Hispanic Youth.

Language Translation - Update

Melissa provided background on the translation process for traffic safety materials. She said that this is part of the ongoing Spanish language translation initiative that started several meetings ago under the direction of Ingrid Londono, HCA Florida Hospital. The top five materials have been identified for translation, the document files have been uploaded, and a vendor has completed translating the materials. Chris Craig provided an update on the accuracy of the translation effort based on input from Ingrid. He said her feedback indicated that another translation effort will be necessary. Chris emphasized that the updated translation materials should be ready for Spanish speaking members of the coalition to review during this fiscal year.

Florida Traffic Safety Resource Center – FTSDC Material Transition

Melissa asked Chris Craig to update the Coalition on the status of the Florida Traffic Safety Resource Center (FTSRC). Chris Craig said it was necessary to change the vendor who was building the Resource Center website which has elongated the timeline for the completion of the FTSRC, where traffic safety materials will be available free of charge to traffic safety partners.

Battle of the Belts

Melissa gave an update on the statewide Battle of the Belts (BOTB) program. She noted that Battle of the Belts was traditionally conducted at the county and local levels, and that this effort is intended to be a turnkey resource for areas that are interested in a Battle of the Belts program, but may not have the resources or local champion to start a program. She said Battle of the Belts consists of a three step process where students observe safety belt usage, conduct an educational campaign, and observe safety belt usage after the educational campaign. Often







there is a significant increase in observed safety belt usage in schools that participate in Battle of the Belts. Melissa said the Florida Occupant Protection Coalition (FOPC) provided their comments on the toolkit in November and that the next step is approval through FDOT Communications. The initial goal was to have the Battle of the Belts toolkit printed this fiscal year, however due to the amount of coordination and approvals need to print at this scale that likely will not happen, however once approved and vendors are solidified, the printing process in subsequent years will be streamlined. Melissa provided an updated timeline of the Battle of the Belts toolkit:

- December 2023-March 2024
 - Review stage
- March-October 2024
 - Printing stage
- October 20-26, 2024
 - Teen Driver Safety Week Campaign where the BOTB toolkit will be a cornerstone of the yearly
- April-May 2025
 - Awards and closeouts

Melissa said that the goal is to have destinations for the kits by the time printing commences.

Participants had the following questions and comments:

- Eric Stern, School District of Palm Beach County, asked how many kits will be printed and distributed?
 - Melissa said that the goal is still 200 kits.
- Jodie Lindsey-Benware, Shands Health UF, asked if there were infographics explaining what Battle of the Belts is?
 - Melissa referred the coalition to the landing page at Battle of the Belts Florida Teen Safe Driving Coalition.
- Karen Pelot asked what is the cost of the program?
 - The Ground Your Parents kit was close to \$250 per kit, but those kits were only made of paper. The BOTB kits will be more expensive since there are many different components to the kits.

Florida Tax Collector Conference

Melissa provided an update on the suggestion that the FTSDC attend the Florida Tax Collector Conference to engage and develop potential partnerships with different tax collectors' offices throughout the state. Due to a variety of factors, the FTSDC is unable to attend this year's conference. She noted that the annual conference will remain on the list of potential engagement opportunities when more accessible and affordable locations are hosting the conference in subsequent years.

Participants had the following questions and comments:

- Eric Stern asked what the benefit of coalition members or representatives of the coalition attending this conference would be?
 - Florida tax collectors' offices oversee driver education in their respective counties. Attending the conference could be an opportunity to provide them with free teen driver safety resources and







connect with leaders that the coalition can partner with to display materials in their offices. This could also build on previous collaborations with FLHSMV where materials that had teen-oriented messages related to Graduated Driver Licensing (GDL) and others are shared by FLHSMV and individual tax collectors' offices select which messages to display.

- Melissa asked if there was any tracking metrics to see which messages were being selected and displayed?
 - Leilani Gruener, FLHSMV, said she would verify if there are any tracking metrics before the next meeting.

Teen Driver Data – S4 Dashboard Update

Melissa displayed traffic crash data utilizing the Signal Four (\$4) Analytics Dashboard to provide a snapshot of crashes involving teen drivers over the course of the year. She said the S4 data indicates that in 2023 there were 79,030 total crashes involving teen drivers with 263 fatalities and 1,710 serious injuries. She noted that since crashes involving teen drivers include personal identification information such as age, the teen crash data is 60 days behind other crash data that does not contain personal identification information. She said this will continue to be a standing agenda item at each quarterly coalition meeting to provide a snapshot of the crashes involving teen drivers.

Participants had the following questions and comments:

- Rich Greene, Columbia River Driver Education, asked if there is a way to determine the portion of fatal crashes involving teen drivers that also involved alcohol impairment?
 - The Cambridge Systematics (CS) data team will verify if this is feasible and add to the 2024 Teen Fact Sheet.

AAA – Safe Systems Conference

Michele Harris, AAA, reminded the coalition about the upcoming Safer Together – AAA Safe System Conference on April 11, 2024 at FDOT District 6 headquarters in Miami-Dade County. More information can be found SAFER TOGETHER - AAA Safe System Conference Tickets, Thu, Apr 11, 2024 at 9:00 AM | Eventbrite

AAA - Legislative Update

Karen Morgan, AAA, submitted a recap of important legislative items and their respective status during the 2024 Florida Legislative Session.

- SB 260/ HB 38 which would require the installation of an ignition interlock device for a driver's first refusal of a breath test.
- SB 1664/ HB 1469 which would ban the usage of a wireless device in a handheld manner while driving. She noted that the house version of the bill is in the Infrastructure Strategies Committee and the senate version of the bill has not gotten a hearing, and is not anticipated to progress further through that
- SB 1764 defines a coordinated street takeover to mean 10 or more vehicles operated in an organized manner in effect constituting a street takeover, increases the fines for participating in a street takeover, increases the fine for spectating at a street takeover, and allows arresting law enforcement to seize any vehicle used in such an event.
- SB 1528 increases penalties for a person who commits a moving violation that causes serious bodily injury or death.

Additionally, Karen noted that several municipalities are exploring banning right-turns at red lights.

Open Sharing

Melissa opened the floor for attendees to provide any updates or news worth sharing to the coalition.

- Chief Art Bodenheimer, Lake Alfred Police Department, referenced an article developed by the International Association of Police Chiefs (IACP) and the Safe Mobility for Life Coalition that received international publication and recognition. He suggested the FTSDC should work with IACP to develop and publish a similar article to showcase the positive impact the FTSDC has had on teens in Florida.
- Jayson Levy, Alachua County Sheriff's Office, emphasized the value of the Teen Driver Safety Challenge administered by the Florida Sheriff's Association. He encouraged those in jurisdictions that do not have an existing program to ask their Sheriff to apply for subgrant funding from FDOT to start a program. He







noted that the program teaches students how to drive safer and better for free. He encouraged participants to share any videos from their areas of students participating in the program.

- Melissa noted to add an Action Step to conduct outreach to areas that do not have a Teen Driver Safety program to the law enforcement section of the Action Plan.
 - Jennifer Hall, Nations Traffic Safety School, said the Teen Driver Safety Challenge is an excellent program that increase teen driver confidence. She noted that if participating teens are under a certain age at the time of participation in the program they may be eligible for free AAA membership. Building off of that could be a collaborative opportunity between the Florida Sheriff's Association and AAA.
- Rachel Silber said a survey conducted among Hollywood Hills students revealed a double standard where students drove differently in front of their parents compared to driving in front of their friends.
- Keith Robbins, FDOT District One Safety Administrator, said a big community safety event is in the works in collaboration with the Lee County Sheriff's Office. He said the intent is to have many pieces of equipment in a touch-a-truck style event that involves all of the FDOT Traffic Safety Coalitions.

Special Needs Driver Education Resources Page – Group Discussion (3B.3)

Melissa updated the coalition on Action Step 3B.3 that identifies opportunities to integrate adaptive needs driver education best practices into pre- and post-licensure driver education programs. She directed the Coalition to the landing page the coalition developed at Driver Education for Adaptive and Special Needs Individuals. She said the page was based off the Association of Driver Rehabilitation Specialists and lists certified driver rehabilitation specialists and provides descriptions of available resources. Additionally, the page will provide a process flow for parents and caregivers for FLHSMV accommodations once the questions are approved by FLHSMV. Melissa thanked Rich Greene for his assistance on this action. She noted that 12 new requests that have come through as result of this landing page with requests inquiring as to what services are provided by FLHSMV. Melissa asked the Coalition for initial reactions to the landing page, as well as feedback to address any potential gaps.

- Cristina Morales, FDOT District 6, said the page could provide resources for other modes of transportation.
- Leilani highlighted the Safe Mobility for Life Coalition's Find a Ride program as well as other mobility options identified through discussions with Gaile Holley who oversees that coalition for FDOT.
- Eric Stern suggested the landing page could display some adaptations available for different vehicle manufacturers and model through a list of adaptive ad-ons.
- John Bolen, Treasure Coast Driving School, referenced a mechanic shop in St. Lucie County that could have experience directing the public to different resources that are available.
- Does insurance cover adaptive components or rehabilitation without endorsing or recommending the adaptations?
 - It likely varies by insurance company and policy.

Marshmallow Challenge - STEM Game

Melissa provided background and instructions for a collaborative team building exercise. The object of the marshmallow game was to build the tallest freestanding structure using the materials provided in 18 minutes. Participants assembled various structures with varying success. After the time limit expired, Melissa and Shaina reviewed each teams structure and selected the winners.







Teen Traffic Safety Subgrants

Chris Craig, FDOT, presented on subgrant funds awarded through the FY2024 Highway Safety Plan Annual Grant Application for teen driver safety projects. He said there were 3,587 fatalities and 16,032 serious injuries statewide in Florida in 2022. He said there were 344 fatalities 1,937 serious injuries involving a teen drivers in 2022. Chris discussed each subgrant funded project in FY24 including:

- Florida Teen Safe Driving Coalition
- Drive with CARE
- Teen Driver Challenge
- **Enforcement Subgrants**

He discussed the challenges related to Teen Driver Safety. Additionally, he discussed the top 40 percent of counties with the highest number of fatalities and serious injuries involving teen drivers that are prioritized for funding. He said additional outreach to increase awareness and subgrant applications is needed in these areas.

Participants had the following questions and comments:

- Eric Stern asked what the range of funding is for a typical subgrant?
 - It varies by agency and what the justifiable need is. There's a wide range based on need. Applicants must justify the funding amount in their concept papers.
- Rachel Silber asked what can residents of counties with agencies not applying or receiving subgrants do to encourage more submissions? If the United Way and Students Against Destructive Decisions (SADD) partnered with a police department, would a subgrant cover the police department's time?
 - It depends, often it is about prioritization. For the Teen Driver Challenge the point of contact is the Florida Sheriff's Association. For educational activities it can depend on the ease of developing partnerships. An enforcement subgrant could cover overtime only.
- Mike Zinn, FDOT District 7, asked what the dollar amount range is for subgrants?
 - Sample concept papers can be found at Concept Papers. Subgrant administrators consider what an agency has spent previously if they are a returning applicant and the number of officers an agency employs among other factors. If the project area is within the top 40 percent of counties and cities as determined by the Highway Safety Matrices, concept papers are evaluated holistically based on need, narrative, and the justification behind the funding amount.
- Mike Zinn noted that several smaller cities contract their police services with the Sheriff's Office of the county in which they are located.
 - The subgrants are intended to address the problem wherever it is identified.







2023 Strategic Action Plan – Subcommittee Group Breakout Sessions

Melissa asked participants to divide into subcommittee groups and review their actions steps in the FTSDC Strategic Action Plan. Subcommittee groups worked collaboratively to report progress on action steps and identify next steps to accomplish prior to the next FTSDC meeting. Each action step leader prepared to provide an update at the closing of the FTSDC meeting. The subcommittees were organized around the following breakout topics and their associated Action Steps.

MEETING NOTES – FEBRUARY 13, 2024

Welcome and Day 1 Recap

Melissa welcomed participants back to Day 2 of the Florida Teen Safe Driving Coalition Meeting. She provided housekeeping updates, reviewed the activities from Day 1, the Day 2 agenda, and the meeting followed.

FTSDC Ambassador Board and Program – Update

Shaina Finkel, FTSDC, provided a recap on the purpose and mission of the Teen Ambassador Board. She said that the ambassador board came into existence after partnering with SADD and recognizing the need for there to be other teens in the room. She also emphasized the importance of program champions and rockstars, while also noting the challenge of students whose school lacked a dedicated champion. Next Shaina discussed the Board selection process noting the quality of the final candidates that were selected. Since they were brought onto the board in October, the board members will attend the June meeting and some may return to serve on the board the following academic year. Then Shaina discussed recent board activities. She provided a recap of the Retreat Weekend that was full of team building and role building activities.
