MEETING NOTES – JUNE 27, 2024

Welcome and Member Sharing

Melissa Hamrick (Valido), Florida Teen Safe Driving Coalition (FTSDC), welcomed attendees and thanked them for their participation. She provided an overview of the coalition's mission and focus area goals, which include:

- Membership
- **Outreach and Education**
- Advocacy and Public Policy

She provided background on each goal and discussed the coalition's aims for each. She asked participants to introduce themselves before reviewing the meeting agenda.

FTSDC Updates and Housekeeping

Melissa provided general updates and housekeeping reminders relevant to the FTSDC.

New Member Announcement

Melissa happily announced that she will be a mother by the end of the year and notified the coalition that she will likely be out of office on maternity leave for the FY25 Q1 meeting. She said that the FDOT team will lead and facilitate the coalition meetings through the beginning of the next fiscal year.

Position Overview

Melissa shared that the FTSDC is adding a Program Assistant through Tallahassee State College (formally Tallahassee Community College). She shared the position posting details and encouraged coalition members to share it through their networks.

Flip Charts

Melissa directed attendees' attention to the flip charts set up around the room. She asked attendees to take opportunities throughout the meeting during breaks, subcommittee breakout times, or after the meeting to provide responses to the questions on the flip charts. She noted that they can be useful for planning meetings in the future.

Membership List Updates

Melissa directed participants to the highlighted names or starred entries on the membership list for website updates. Melisa said that Shaina Finkel, FTSDC, was passing out a list that determined whether attendees needed to provide additional information to be included on the FTSDC website.

Parent/Teen Folder Mailing (FLHSMV MOU)

Melissa gave an update on the Safe Driving Guide for newly licensed teens and provided an overview for new coalition members. She said this folder mailing is an agreement between parents and teens to be distributed to parents of new teen drivers between the ages of 15 and 17. As of June 2024, 163,201 folders have been distributed. She emphasized the increase in the number of mailings distributed with a target of 265,000 folders.

Participants had the following questions and comments:







- Jennifer Hall, Nations Traffic Safety School, asked when the most recent distribution occurred and worried that some teens may be missed in the interim between quarterly distributions.
- The most recent distribution occurred in March. Once June ends, the Florida Department of Highway Safety and Motor Vehicles (FLHSMV), will send the list of newly licensed teens ages 15-17 for the months of April, May, and June. It usually takes 15 days after the end of the third month for the list to be finalized and received before the print order can be placed and the folders mailed.
- Chris Craig, Florida Department of Transportation (FDOT), emphasized that the process is being finetuned with FLHSMV to eventually send the list of newly licensed teens on a monthly basis. However, there is already substantial coordination for the list to be sent on a quarterly basis. He emphasized that the list includes personal identifiable information and only he is allowed to see the list before placing the print order. He noted that the quarterly distribution takes a substantial amount of time and effort for both agencies.
- Melissa said that one of the Action Plan steps is to make this folder mailing more readily available through the tax collector's offices.
- Leilani Gruener, FLHSMV, said that she proposed the idea at the recent tax collector meeting held by FLHSMV. She is expecting more requests to come from the sharing of the materials at that meeting.

New Printed Materials – Updates

Melissa provided updates on new printed materials for education and outreach related to submerged vehicle safety and best practices. She praised Erin McDade, FDOT, for her collaboration in working with FDOT Communications noting that the most recently discussed printed materials had all been formally approved and are moving to the printing stage. Additionally, the "Buckling Up -Why Should I" rack card and the stand alone "Parent and Teen Safe Driving Contract" were also approved and are moving to print. Other materials in development include educational materials for street racing, railroad crossings, drowsy driving, and golf carts.

Week of Awareness Presentations – Updates and Upcoming Tour Information

Melissa provided an update on the yearly Weeks of Awareness Campaign. For the current fiscal year, 60 presentations were given reaching 29,773 students. She provides the backgrounds on the respective speakers. She noted that the locations are prioritized based off of the FDOT Highway Safety Matrix that is updated and published each year. For the following fiscal year, Melissa said the coalition is targeting 70 presentations total with the following number of presentations in the following locations:

- Orange County 20
- Miami-Dade County 20
- Hillsborough, Pinellas, and Pasco counties 10
- Broward and Palm Beach counties 10
 - Duval County 10, funded by State Farm

Participants had the following questions and comments:

- Andre Jamison, Drive Trainer, asked if the coalition was looking at schools outside of the public school system?
 - Public high schools are the priority locations. While open to coordinating presentations in schools outside of the public school system, sometimes there is not a large enough audience of 400 or more students and additional caveats come into play that present unique challenges to booking the Weeks of Awareness presentations at non-public schools.
- **Language Translation Update**







Melissa provided background on the translation process for teen traffic safety materials. The second round of translations from the new vendor will be available for the coalition to review soon. Once the accuracy of the translating vendor is established and the coalition becomes comfortable with that vendor the top materials will be translated on an ongoing basis, but the right vendor needs to be selected.

Battle of the Belts - Update

Melissa gave an update on the statewide Battle of the Belts (BOTB) program. She noted that Battle of the Belts was traditionally conducted at the county and local levels, and that this effort is intended to be a turnkey resource for areas that are interested in a Battle of the Belts program, but may not have the resources or a local champion to start a program. She said Battle of the Belts consists of a three-step process where students observe safety belt usage, conduct an educational campaign, and observe safety belt usage after the educational campaign. Often there is a significant increase in observed safety belt usage in schools that participate in Battle of the Belts. Melissa displayed and described the contents of the Battle of the Belts kit by section. Next she discussed the timeline for this project. The kit was approved and promoting the kit is ongoing with a landing page that will be promoted starting in July, noting that there are 52 commitments for the kits already. Melissa emphasized that there is no deadline to order the kits, but that there is a hard limit of 200 kits that will become available on a first-come-first served basis. More information can be found at Battle of the Belts - Florida Teen Safe Driving Coalition.

Melissa provided an updated timeline of the Battle of the Belts toolkit:

- December 2023-June 2024
 - Review and approval stage
- June-October 2024
 - Printing stage
- October 20-26, 2024
 - Teen Driver Safety Week Campaign where the BOTB toolkit will be a cornerstone of the yearly campaign.
- April-May 2025
 - Awards and closeouts

Participants had the following questions and comments:

- Rachel Silber, Hollywood Hills High School, asked if the pre and post survey questions are available in Spanish?
 - Melissa and Rachel will meet to discuss translating the survey documents. A Spanish translation of the full kit can be added to the Action Plan at a future meeting.

State Farm PSAs - New Project

Melissa provided background on a new initiative being funded by State Farm. The initiative consists of funding for four new traffic safety focused public safety advertisements (PSAs). She provided an overview of the four PSAs and noted that each one has been successfully storyboarded. The goal is to have the PSAs ready for Teen Driver Safety Week.

Lifesavers 2024 - Update

Melissa provided an update from the 2024 Lifesavers Conference on Roadway Safety held in Denver, Colorado from April 7-9th. She discussed her involvement on a panel titled Navigating the Road Together: Parent Teen Relationship's Impact on Safe Driving Practice and provided an overview of the positive feedback received from her and Shaina's respective presentations.

Teen Driver Data – S4 Dashboard Update







Melissa displayed traffic crash data utilizing the Signal Four (S4) Analytics Dashboard to provide a snapshot of crashes involving teen drivers over the course of the year. She said the timeframe of the most recently available data is November 10th-April 25th of this year. Over that time frame there were 28,438 crashes involving a teen driver with 83 fatalities, 607 serious injury crashes, 3,400 non-serious injury, and three non-traffic fatalities. She noted that since crashes involving teen drivers include personal identification information such as age, the teen crash data is 60 days behind other crash data that does not contain personal identification information. She said this will continue to be a standing agenda item at each quarterly coalition meeting to provide a snapshot of the crashes involving teen drivers. She noted that crashes involving teen drivers are predominately occurring during the day, with 74 percent of crashes. Tuesday through Friday between the hours of 12pm and 8pm are the peak times for crashes involving teen drivers. Additionally, 278 of crashes involving teen drivers also involved alcohol, distraction is not quantified, and additional queries for the level of speed and presence/number of passengers could provide insights after taking deeper dives into the data.

AAA – Legislative Update

Melissa presented a recap of important legislative items and their respective status during the 2024 Florida Legislative Session from a presentation developed and submitted by AAA. She said that over the past ten years there were 31,166 fatalities on Florida's roadways with 3,393 occurring in 2023 alone. Additionally, it is estimated that the annual cost due to motor vehicle damage is \$20.019 billion. Because of this the following items are considered to be AAA's and other stakeholders' priorities:

- Primary Enforcement of a rear seat belt law
- All rider motorcycle helmet law
- Rear facing child passenger seat requirements through age 2 or more
- Booster seat law
- Rear seat requirements for children through age 12 law
- Passenger restrictions provisions
- Installation of ignition interlock devices for all DUI offenders
- Graduated Driver License and cell phone restrictions

She noted that the FTSDC's focus is on the development of educational resources and programs. While important to stay aware of legislative activity, the FTSDC does not participate in legislative or lobbying activities.

Upcoming Observances

Melissa reviewed the upcoming traffic safety observances for the months of June, July, and August.

- June
 - 100 Deadliest Days
- July
 - 100 Deadliest Days
 - 4th of July (Impaired Driving)
 - Southern Slow Down Speed Campaign (July 8-31)

 - 100 Deadliest Days
 - Stop on Red Week August 4-10







- Impaired Driving Awareness (August 14-September 2)
- Brake Safety Week (August 25-31)

FTSDC Teen Fact Sheet

Melissa said the 2023 Fact Sheet is available on the FTSDC website and that the 2024 Fact Sheet will be presented by Cambridge Systematics (CS) during the Q4 meeting. She emphasized that many of the deep dive considerations discussed during the S4 dashboard snapshot are delved into in the fact sheet. Additionally, there are not any substantial changes in the overall trend that the FTSDC, other traffic safety coalitions and Florida have been documented over the past several years.

Challenge Coins

Chris Craig presented the FTSDC with honorary challenge coins to recognize the efforts of the coalition. Melissa noted that next year the coalition will shift into updating the Strategic Action to build off the strides made under the current plan.

Open Sharing

Melissa opened the floor for attendees to provide any updates or news worth sharing to the coalition.

- Petra Stanton, Johns Hopkins All Children's Hospital, shared that her daughter chose to give a presentation on autonomous vehicles, emphasizing the impact education and awareness can have on teens.
- Keith Robbins, FDOT District 1, discussed outreach conducted with Janice Martinez, Florida Law Enforcement Liaison (LEL) District 1, Theresa Chestnutt, the Polk County Sheriff's Office and Polk County School Board to conduct traffic safety education in 17 public high schools with two-hour long classroom sessions four days a week, for ten weeks in the spring and ten weeks in the fall. He said this was modeled after the Teen Driver Challenge that is overseen by the Florida Sheriffs Association. In Lee County, there was a Spring into Safety event that included touch a truck opportunity where over a three-hour period 500 to 1,000 people attended the event. He noted that Shaina and Shyla from the FTSDC Teen Ambassador Board volunteered and helped table the event.

Do the Math – Save a Life (Lifesavers Program)

Melissa provided an overview of a program supported by the Idaho Transportation Department (ITD) that was presented at the 2024 Lifesavers conference. The program could potentially provide ideas for additional strategic action steps. Do the Math – Save a Life is a Science, Technology, Engineering, and Math (STEM) based program that is conducted through the Idaho Department of Education and a credit union. The program consists of a six-part lesson plan that describes how Idaho Department of Transportation safety data can be used by school math departments to engage students in math and traffic safety simultaneously. Melissa provided a high-level overview of the contents of each part of the lesson plan and provided a QR code link to the full curriculum. Melissa concluded her overview of the program asking the coalition if this could be something a subcommittee explores further by reviewing the process and materials in the program and evaluate the applicability and feasibility of adapting this program to the Florida context. An additional component of the subcommittees' work would be to increase municipal and local agency stakeholder participation. The following coalition members volunteered to be on the subcommittee:

Participants had the following questions and comments:

- Eric asked if the content aligns with Florida Department of Education standards? Would developing benchmarks to reach those standards be a useful first step?
 - Andre noted that if the FTSDC were to adapt something similar the content would be adapted to meet Florida's context and educational standards.
- Derek Stewart, Florida Virtual School (FLVS), said that FLVS writes lessons from a unique approach with instructors that are aiming to be rated as effective and to exceed expectations. Teachers are looking for new engagement techniques and this model could be applied in other topical areas such as economics or government in addition to or instead of math.
- Jennifer Hall said that another application of this approach could be through extracurricular organizations such as the math club or Student Government Association.
- Amy emphasized the importance of K-8 since the benchmarks are written from a K-12 framework so that the benchmarks build on each other.
 - Melissa emphasized that the focus of the FTSDC is on teens ages 14-19, but sees the value in not discounting K-8. The high school audience would have more math intensive content necessitating the creation of benchmark appropriate lesson plans.
- Melissa asked how this program could incorporate a call to action for teens to start conversations with their parents about traffic safety?
 - Petra noted that the content could be tailored to other subjects like English Language Arts (ELA) in addition to math.
 - Derek emphasized the importance of early education noting that teens should be made aware of traffic safety long before driving. He said this program provides an opportunity to do just that and that turnkey examples for teachers that are sensitive to standards would be helpful.
- Cristina Morales, FDOT District 6, said that this has applicability to Safe Routes to Schools programs that submit for funding of projects that improve students' safety in utilizing active transportation to travel to school. Collaborating with Safe Routes to Schools coordinators could be an avenue to include an adapted project as part of a project application.

Teen Ambassador Board Program – Report Out

Shaina introduced the Teen Ambassador Board Program. She provided background on the application process for creating the board. Each teen ambassador introduced themselves, their backgrounds, and interests. The Teen Ambassador Board members are as follows:

- President Nihal K. Allen D. Nease High School
- Vice President Caroline C. Maclay High School
- Secretary Whitney M. Florida Virtual School (FLVS)
- Engagement and Recruitment Chair: Swathi S. Steinbrenner High School
- Social Chair Shyla H. Boone High School

The Teen Ambassador Board discussed their goals and accomplishments as a group. Their beginning goals were to have 500 social media followers, 100 ambassador program members, and attend 50 driving related events. As of June, the Ambassador program had gained 491 social media follows, 81 ambassador program members, and attended 57 driving events, with Secretary Whitney attending 50 of the 57-event total from all Board members. Some campaigns the Board participated in and engaged students through were awareness of Florida's updated Move Over Law, that requires motorists to move over a lane or slow to 20 miles per







hour below the posted speed limit for all stopped vehicles, as well as create social media posts for every Teen Ambassador meeting with content that followed FDOTs Traffic Safety Campaign Calendar. Board members also participated at the local level through their respective high schools such as the Teen Driver Challenge in St. Johns County and creating a Teen Ambassador Program at Maclay High School.

Each member of the Board shared highlights from their involvement so far and provided a preview of future initiatives. For the upcoming school year, the Board is aiming to increase the number of members to over 200 with half of those members attending monthly meetings, implement more traffic safety events in members' communities, and create new weekly social media content. The Board members shared how each of the 67 counties in Florida would be a board member's responsibility to engage.

Participants had the following questions and comments:

- How is the response to the engagement conducted, how is that feedback processed, and incorporated into ongoing and future activities?
 - The most common response is that high school students do not have enough time. Hearing that, the Board
 emphasizes that the monthly meetings are a low time commitment given the importance of the focus of the
 program which is to save lives.
- Derek asked how geographically diverse the Ambassador program is? Of Florida's 67 counties, how many have at least one ambassador?
 - As of June, 18 counties in Florida had at least one ambassador. The Board intends to increase this number. It is a challenge to know the status of teen driving education and awareness in all counties, but that perspective is why having membership across the state is important. Additionally, there is not a limit on the number of ambassadors that can join from each county. The high-crash priority counties of Miami-Dade, Orange, and Duval counties are likely to have more ambassadors than other lower crash counties.
- Who was the most helpful resource within the schools that the Board engaged to promote the program?
 - o The School Resource Officers and school counselors were the most helpful.
- Keith recommended that the Board Members organize their geographic outreach activities based on the FDOT Districts.
- Eric asked if the Board members had witnessed the effectiveness of their messaging with other teens or siblings where
 they took initiative to change adult behavior and recommended that the Board document how their work is impacting
 younger and older generations.
 - Younger siblings and other teens that look to the Board members as role models are more aware from being engaged with traffic safety messaging.

2023 Strategic Action Plan – Subcommittee Group Breakout Sessions

Melissa asked participants to divide into subcommittee groups and review their actions steps in the FTSDC Strategic Action Plan. Subcommittee groups worked collaboratively to report progress on action steps and identify next steps to accomplish prior to the next FTSDC meeting. Each action step leader prepared to provide an update at the closing of the FTSDC meeting. The Subcommittee Action Steps are listed below:

MEETING NOTES – JUNE 28, 2024

Welcome and Day 1 Recap

Melissa welcomed participants back to Day 2 of the Florida Teen Safe Driving Coalition Meeting. She provided housekeeping updates, reviewed the activities from Day 1, the Day 2 agenda, and the meeting followed.

Florida Teen Safe Driving Coalition Awards

Melissa and Shaina presented the FTSDC awards to the following members:

Teen Ambassador Board – Personal Project Summary

The Teen Ambassador Board Members shared summaries of their personal projects that they undertook as part of their responsibilities as Board members.

Shyla's personal project consisted of a clear, concise, and visually engaging educational video on traffics safety topics. Project setbacks included the choice of what video creation software to use, a learning curve for the animation functionality within the video software, and the distribution mechanism of the video. Initially, Shyla said the videos were scheduled to be run at the end of all fourth period classes, but due to testing schedules that timeslot had to shift, necessitating Shyla to pivot to reaching out to individual teachers to show the video in their respective classrooms. In total, 1,164 students took the survey linked at the end of the educational video consisting of 132 freshmen, 374 sophomores, 501 juniors, and 157 seniors. Some key takeaways from the survey responses included awareness that students' choices have a large impact on their lives, the importance of keeping eyes on the road, and never using a handheld phone while driving.

Caroline's personal project consisted of creating a Teen Safe Driving club that would film an educational video with the Tallahassee Police Department (TPD) at her high school. Approximately 20 students attended the first club meeting with close to half of those students staying in the club. The club's social media account gained 100 followers and 20 homeroom classes watched the TPD video with an estimated 400 views. Caroline's goals for next year are to coordinate with other high schools in the area to help them create Teen Safe Driving Clubs.

Whitney's personal project consisted of a multi-county informational fair. She created a dashboard detailing the motivation behind the project. She provided a timeline of her outreach efforts to secure vendors. Ultimately, 12 vendors participated in the fair and 250 students attended. Challenges to this project included budget and time constraints, as well as moving past multiple rejections from vendors to the vendors that said yes.

Nihal's personal project consisted of a five-part video series discussing different traffic safety topics in two-to-three-minute increments. Topics included distracted driving, speeding, driving under the influence, safety belt use, and road awareness. Nihal discussed the content and approach of each of the five videos. At the end of each video, there were follow up links to the FTSDC website encouraging students to join the Ambassador Board. Additionally, a survey was incentivized for students to take part in that assessed their knowledge before and after viewing the videos. Overall survey respondents included 395 freshmen, 292 sophomores, and 322 juniors.

Swathi's personal project consisted of a Driving Safety Fair at her high school. She discussed the goals, plan, and proposal to implement the safety fair through collaboration with school administrators. A survey of 140 students was also included as part of the outreach effort with 70 percent of students confident in their driving abilities and 93.6 percent of students confident in their driving education. Additionally, 70 percent of student respondents said they had never driven over the speed limit, 50 percent said they played loud music while driving, and 13.6 percent said they drove under the influence. Lastly, 22 percent said they did not believe that their friends drive safely.







Participants had the following questions and comments:

- Cristina praised the students and encouraged them to continue collaborating with students in their areas.
- Keith asked if the Board would share the informational videos to utilize them in high school outreach initiatives?
 - Yes, the videos can be shared.
- Petra asked if the animation software used in one of the projects was a paid service?
 - The video editing service used only requires users to create an account.
- Megan asked if the Board members are reaching out to students or administrators when initiating these programs? She assumed that there would be barriers to talking with administrators and that student connection would be a more successful avenue for engagement.
 - It varies, but often there was more success with reaching out to administrators, but several of the Board members also talked with their friends and leveraged existing relationships.
- Chief Art Bodenheimer, Lake Alfred Police Department, asked if the students faced any challenges with their School Resource Officers (SROs)?
 - It varied by agency. Tallahassee Police Department and St. John's County Sheriff's Office were collaborative and helpful. Some other SROs were difficult to initiate a conversation with, but once contact was made actively engaged. Some agencies contacted by the Board members were unresponsive.
- David asked what the Board members are doing next?
 - There will be more in-person events and less virtual meetings. The Board members have reorganized how they will engage with Florida's 67 counties, by following the FDOT Districts. The Board members present decided that Nihal would be the District 2 contact, Caroline would be District 1, and Swathi would be District 7.
- Kevin Howard, Safe Kids Treasure Coast, asked Nihal about the participation and level of engagement from young men since young men are often the demographic most often involved in crashes.
 - Nihal noted that despite pop culture depictions of speeding and fast cars as cool and exciting, young men at his school are realizing that is not the case from hearing personal stories of police chases. At first it was predominately women engaging with the Board, but over time more young men joined.
