MEETING NOTES – JUNE 27, 2024

Welcome and Member Sharing

Melissa Hamrick (Valido), Florida Teen Safe Driving Coalition (FTSDC), welcomed attendees and thanked them for their participation. She provided an overview of the coalition's mission and focus area goals, which include:

- Membership
- Outreach and Education
- Advocacy and Public Policy

She provided background on each goal and discussed the coalition's aims for each. She asked participants to introduce themselves before reviewing the meeting agenda.

FTSDC Updates and Housekeeping

Melissa provided general updates and housekeeping reminders relevant to the FTSDC.

Flip Charts

Melissa directed attendees' attention to the flip charts set up around the room. She asked attendees to take opportunities throughout the meeting during breaks, subcommittee breakout times, or after the meeting to provide responses to the questions on the flip charts. She noted that they can be useful for planning meetings in the future.

Membership List Updates

Melissa directed participants to the starred entries on the membership list to update the bio section of the FTSDC website. Melisa said that Brandy French, FDOT, was passing out a list that determined whether attendees needed to provide additional information to be included on the FTSDC website.

Teen Ambassador Program 2024/25 Recruitment

Melissa directed the coalition members' attention to the Teen Ambassador Board informational hand out. She provided background on the difference between the Ambassador Board and program members. She detailed what the ambassador requirements are and what qualities the FTSDC is looking for in board member and program candidates. She noted that applications are open and to expect a mass email to be sent out to the coalition to encourage applications. Interviews for the positions will likely be held the week of September 23rd-27th and a hiring decision will be made by September 30th. The new Ambassador Board will be announced during Teen Drive Safety Week on October 21st.

Parent/Teen Folder Mailing - Update (FLHSMV MOU)

Melissa gave an update on the Safe Driving Guide for newly licensed teens and provided an overview for new coalition members. She said this folder mailing is an agreement between parents and teens to be distributed to parents of new teen drivers between the ages of 15 and 17. As of August 2024, 217, 719 folders have been distributed exceeding the 2022-2023 distribution total of 208,910. She attributed the increase in the number of folder distributions to the fact that this year the folders were distributed on a quarterly schedule rather than the three distributions from the previous year. The final year end distribution target is 265,000.

Language Translation - Update

Melissa provided background on the top five traffic safety materials prioritized to be translated into Spanish and eventually Creole. She asked Chris Craig, Florida Department of Transportation, (FDOT) to provide a status update on the language translation process. Chris said that a new vendor was hired to more accurately translate the top five materials and that the latest versions were received last week. The next step will be to have friends







of the coalition who are fluent in Spanish review the translated materials for their accuracy. He also said that the focus is on ensuring the accuracy of the Spanish translation before exploring Creole translation.

Battle of the Belts - Update

Melissa gave an update on the statewide Battle of the Belts (BOTB) program. She noted that Battle of the Belts was traditionally conducted at the county and local levels, and that this effort is intended to be a turnkey resource for areas that are interested in a Battle of the Belts program, but may not have the resources or a local champion to start a program. She said Battle of the Belts consists of a three-step process where students observe safety belt usage, conduct an educational campaign, and observe safety belt usage after the educational campaign. Often there is a significant increase in observed safety belt usage in schools that participate in Battle of the Belts. Melissa displayed and described the contents each section of the Battle of the Belts toolkit. Next she discussed the project's timeline. Since approval, promotion of the kit is ongoing. She noted that there are already 52 commitments for kits. Melissa emphasized that there is no deadline to order the kits, but that there is a hard limit of 200 kits that will become available on a first-come-first served basis. Melissa provided an updated timeline of the Battle of the Belts toolkit:

- December 2023-August 2024
 - Approval stage
- September-October 2024
 - Printing stage
- October 20-26, 2024
 - Teen Driver Safety Week Campaign where the BOTB toolkit will be a cornerstone of the yearly campaign.
- April-May 2025
 - Awards and closeouts

Participants had the following questions and comments:

- Megan Hawkins, HCA Florida Hospital, asked if the infographic that lays out the content of the map is available?
 - Melissa said that infographic will be included in the kit. The website will be the primary source for directing people to information related to the program.
- Janice Martinez, Florida Law Enforcement Liaison (LEL) District 1, asked what is the timeframe for the pre and post engagement survey and if there is a preference for when in the year the program is conducted?
 - Melissa said there is no prescribed amount of time to conduct the pre and post surveys, but they are typically administered over two-three weeks. October is the earliest it can be done and April or May is the latest, the BOTB subcommittee will discuss this further.
- Petra Stanton, Johns Hopkins Children's Hospital, suggested that providing implementation examples could be useful especially if the kits provide an optimal time of year to focus on the campaign.
- Janice suggested that participants could receive bonus points for conducting campaigns during both the fall and spring semesters.
 - The challenge with incentivizing them to do both semesters and what differentiates this from the Ground your Parents folder and campaign is that the BOTB toolkit is intended to serve the entire school rather than individual students, so there is a limit on the number of citations and commendations that can be given through the toolkit.







NTSB - Tribal Youth Listening Session

Melissa provided an update on a collaborative effort with the National Traffic Safety Board (NTSB). The collaboration consists of FTSDC assistance in facilitating a listening session on traffic safety issues. The listening session is tentatively scheduled for September 17, 2024 from 12-1pm Eastern Standard Time (EST). Melissa noted that it is a national opportunity for tribal youth to participate. Additionally, the listening session will be broadcasted live and will be recorded. For more information can be found by contacting Bryan Delaney at Bryandelaney@ntsb.gov

Teen Driver Data - S4 Dashboard Update

Melissa provided a snapshot of the most up to date data available through the Signal Four (S4) Analytics Dashboard. As of June 2024, there were 115 fatal, 740 serious injury, and 36, 143 total crashes involving teen drivers. She compared the crash data to the other demographically based safety emphasis area for which crash data is available. She noted that Friday is the day of the week when there was the highest incidence of crashes involving teen drivers. She emphasized that crashes involving teen drivers remain relatively high throughout the year in contrast to the national 100 Deadliest Days for Teen Drivers between Memorial and Labor Day. The S4 heat maps illustrate that crashes are more prevalent in areas with more population. Melissa noted that 353 crashes involving teen drivers also involved alcohol, most of which occurred at night.

AAA – Legislative Update (Karen Morgan)

Melissa reviewed the legislative update provided by Karen Morgan (AAA) from the previous coalition meeting and noted that there were no further legislative updates since the previous meeting.

The legislative update provide by AAA at the previous meeting noted that over the past ten years there were 31,166 fatalities on Florida's roadways with 3,393 occurring in 2023 alone. Additionally, it is estimated that the annual cost due to motor vehicle damage is \$20.019 billion. Because of this the following items are considered to be AAA's and other stakeholders' priorities:

- Primary Enforcement of a rear seat belt law
- All rider motorcycle helmet law
- Rear facing child passenger seat requirements through age 2 or more
- Booster seat law
- Rear seat requirements for children through age 12 law
- Passenger restrictions provisions
- Installation of ignition interlock devices for all DUI offenders
- Graduated Driver License and cell phone restrictions

Melissa noted that the FTSDC's focus is on the development of educational resources and programs. While important to stay aware of legislative activity, the FTSDC does not participate in legislative or lobbying activities.

Week of Awareness Presentations – Updates and Open Discussion

Melissa provided an update on the yearly Weeks of Awareness campaign. For the current fiscal year, 60 presentations were given reaching 29,773 students. She provided the background on the respective speakers. She noted that the locations are prioritized based off of the FDOT Highway Safety Matrix that is updated and published each year. For the following fiscal year, Melissa said the coalition is targeting 70 presentations total with the following number of presentations in the following locations and the timeframe

- Orange County 20
 - November 11-22, 2024







- Miami-Dade County 20
 - Dates to be determined
- Hillsborough, Pinellas, and Pasco counties 10
 - Dates to be determined
- Broward and Palm Beach counties 10
 - February 24-28, 2025
- Duval County 10, funded by State Farm
 - October 21-25, 2024

After discussing next fiscal year's approach for the Weeks of Awareness program, Melissa described the barriers and challenges planning and implementing the yearly Weeks of Awareness program. She said coordinating the speakers' and school schedules is time consuming, and emphasized that schools can and often unfortunately cancel without enough notice to reschedule, despite multiple confirmations and touch points leading up to the presentations. Additionally, the message has saturated the schools in the high population and high crash areas. The logistical coordination required to align multiple rural areas is not tenable either. Other challenges include additional permission requirements at the school level, buy-in from community partners ebbs and flows, attendance can vary, and schools have many competing demands that can result in traffic safety awareness presentations being deprioritized. Melissa then opened the discussion up to the rest of the coalition for brainstorming about the future of the program with the question of could the time spent on Weeks of Awareness be better spent on making more educational safety kits like Ground Your Parents and Battle of the Belts, but for other teen driver safety topics?

Participants had the following questions and comments:

- The coalition agreed that focusing on improving the distribution network to more effectively collaborate with Tax Collector's Offices is a good strategy as well as asking teens directly about what is effective for traffic safety programming.
 - Chief Art Bodenheimer, Lake Alfred Police Department, noted that Tax Collector's offices priorities can change based on local election outcomes.
- Karen Pelot, Always Wear Your Seatbelt Foundation, said that many school boards want the presentations, but they are often overbooked with priorities that are mandated by the State.
- Derek Stewart, Florida Virtual School (FLVS), suggested considering how to pair Weeks of Awareness with other programming and driver education opportunities.
- Keith Robbins, FDOT District 1, agreed that programming could be focused in a targeted area and paired with driving education, similar to Sheriff's Offices that participate in the Teen Driver Challenge. He said programming that resembles the Battle of the Belts toolkit would be useful particularly around orientation at the start of each semester. He also suggested that if Weeks of Awareness does continue, to reach out to contacts in FDOT District 1 that can get the buy in from school superintendents as well as school board support. Additionally, could the contracts with the speakers allow for virtual options to decrease the cost of traveling from another state or increase the amounts and terms so there is more flexibility in booking the presentations outside of week long time slots?
 - Melissa responded that the speakers likely see more value from in-person presentations and are unlikely to want to share their often heart wrenching personal stories through a virtual or remote option, especially if being recorded and shared online. Additionally, the impact of virtual presentations can be challenging to quantify and may not increase the longevity of that impact. Also, what the speakers want for virtual options may not align with what is available through the National Highway Traffic Safety Administration (NHTSA).
- Rich Greene, Columbia River Driver Education, asked where the audience requirement originates?







- Melissa said that prior to March 2019, the audience requirement was double what it is today with 800 required audience members. The minimum audience size is due to the cost of the presentation.
- Jennifer Hall, Nations Traffic Safety School, mentioned that Student Government Associations have annual conferences that the coalition could incorporate into its outreach strategy as potential venues.
 - Melissa said that being worthwhile depends on the estimated audience attendance to those conferences as well.
- Andre Jamison, Drive Trainer, said that although it likely will not have the same numerical impact, a wellproduced video presentation could be utilized in driver's education courses as well in tax collector's offices once you have well produced video presentation, you can play it every drivers ed course in every school.
 - Melissa said that the finite viewing opportunity is what makes the presentations valuable and worthwhile for the speakers. A video of their presentation, even if well-produced, is unlikely to capture it in the same way.
- Melissa noted that the challenge with making changes at this point in the fiscal year is that the contracts are drafted in October to be written into the concept papers that are submitted to FDOT in February that are then incorporated into FDOT's Annual Grant Application (AGA) and submitted to NHTSA for approval by August.
- Leah Othmer, Safe Kids Northeast Florida, Player's Center at Wolfson Children's Hospital, noted that the fall semester is shorter and asked if there were opportunities for booking presentations during the spring semester?
 - Melissa said that the school districts set the schedules. The bulk of the testing and events are held during the spring semester. There has been a constant tension between the school and speakers' calendars over the past seven years.
- Is there any focus on 18 and 19 year olds?
 - College students and 18-19 year olds fall out of the FTSDC's demographic focus as determined by NHTSA/FDOT.
 - Chris Craig also noted that in other engagements for other emphasis areas the challenge is reaching enough of the student body at one time in the college context.

December Meeting Survey Reminder

Melissa reminded the coalition about the importance of registering for the coalition meetings. She said that the comment box within the registration email is useful for members that travel farther distances or are participating in extra subcommittee meetings. She noted that the Driver Education Subcommittee will be sent two separate registration sing ups. She elaborated on the difference between the block room rate and members' paying for their own hotel room, noting that the block room booking option provides a group rate and breakfast voucher.

Open Sharing

Melissa opened the floor for attendees to provide any updates or news worth sharing to the coalition.

- Art said he represented the FTSDC at the Florida Association of School Resource Officers (FASRO) conference with Tim Roberts, Florida Law Enforcement Liaison (LEL) Coordinator, and Jon Askins, LEL District 5. Art said that the conference was attended by 770 School Resource Officers (SROs). He said that the line officers that need traffic safety materials are not getting them and that it is an ongoing effort to get the right materials to those front line officers.
 - o Jon emphasized that consistent engagement with SROs is challenging because SROs tend to be in a specific school for a short amount of time, as the SROs are rotated between different schools.
 - Melissa thanked the coalition's law enforcement members for representing the FTSDC at the conference.
 - Art said many of the other safety booths spent time engaging with him, Tim, and Jon exploring different partnership and collaboration opportunities. An improved safety booth for the FTSDC at FASRO would also be helpful.
 - Jon said that the Ground Your Parents folder and other materials were well received by the other conference attendees.
- Darren Tessitore, Foundation for a Drug Fee World, said that materials produced by his foundation are available to share.
- Karen gave a reminder about the Always Wear Your Seat Belt Foundations' Lace-Up To Buckle-Up 5K Run/Walk which is scheduled for October 19th in Belle Isle, FL. She said it is the ninth annual 5K and to look out for an email blast soon.







Florida Virtual Schools (FLVS) Telematics Driving Data Research/Presentation

Derek discussed a recently completed study conducted by FLVS to assess the impact of FLVS driver education using a telematics data solution. Once completed, the results of the study can be applied to coalition members' organizations. Derek asked how success is measured for FLVS Driver Education and suggested that the impact of that education should be tied to the specific outcome of FLVS students consistently demonstrating risk reducing strategies and proper driver behavior. He noted that traditionally driver education is assessed based off crash data, traffic citations, and self-reporting. These measures are limited because crash data provides a snapshot in time, traffic citations are variable, and self-reporting is unreliable. Because of these limitations, the research question posed by Derek and his team became: "What is the impact of FLVS Driver Education on driving performance as measured by a telematics solution." Telematics, he said, show how drivers are behaving in the real world with contributing factor data that is timely, accurate, and longitudinal. With that research question, the research team compared the driving performance of students who completed FLVS Driver Education with student drivers who did not take FLVS Driver Education to validate the FLVS curriculum or provide data supporting potential changes to that curriculum.

Next, Derek discussed the research process. The team submitted a proposal and literature review to get approval to conduct the study. The methodology of the study consisted of including a QR code that navigates to the telematics app as part of the post driver education follow up information given to students on completion of the course. The telematics app provider then verifies this group of drivers within its data.

So far the data gleaned from the study is that between FLVS students and non-FLVS students there is a slight different in the aggregated safe driving score that takes into account speed, focus, swerving, phone use, acceleration, cornering, steadiness, and braking into an average score. Despite this difference, the research team has not put the results through a statistical process to determine the significance of that difference.

Next steps include a detailed data analysis, peer review, and publication. Derek concluded that the focus of this study is on effectiveness, measuring outcomes, and data driven decision-making.

TLSAE Legislative Review Discussion

Danny Shopf, Cambridge Systematics (CS), droned on about the Traffics Law and Substance Abuse Education (TLSAE) Model Language Document. He reviewed each section of the model language document including the overview, existing Florida Statute, and the proposed changes to Florida Statute that would align the statute with national standards and best practices. The coalition accepted the proposed model language changes. Danny and Melissa emphasized that the FTSDC does not advocate or engage in the legislative process beyond developing model language.

Participants had the following questions and comments:

- Chris Earl, National Safety Council, asked if new drivers regardless of age are required to take and complete the TLSAE course?
 - Derek said yes, unless coming from a state with a reciprocal agreement.

2024 Teen Fact Sheet Overview and Discussion

Alan Amidon, CS, gave a riveting presentation to resounding applause presenting the 2024 Update of the Teen Driver Fact Sheet. The fact sheet helps identify target audiences and provides context for Florida's Teen Driver Safety challenges. The Fact Sheet is readily available for the coalition to use.

He noted that the fatal crashes involving teens is trending downward, following the statewide trend for fatal crashes. Likewise serious injuries involving teens and all types of serious injury crashes continue to trend downward. Alan emphasized that 2020 data continues to be an outlier.

Alan reviewed the Day of Week crash data, noting that Friday, Saturday, and Sunday continue to be days when more fatal crashes involving teens are occurring. Despite this, he said that overall crashes involving teens are lower on the weekends, but that the







crashes occurring over the weekend are more deadly and likely involve high risk behaviors such as speeding, impairment, and potentially drowsy driving.

He reviewed the Month-by-Month crash data noting that the months of October, November, March, and May are the months when more crashes involving teens are occurring.

Alan broke down the crashes by different ages saying that the number of crashes and crash severity increases as teens age and develop a false sense of confidence.

Consistent with prior fact sheets, the Top 15 Florida counties for fatal crashes, serious injury crashes, and overall crashes involving teens continue to be the most populous counties within the state. Miami-Dade County had the most fatal crashes involving teens as well as the most overall crashes involving teens. Orange County had the most serious injury crashes involving teens. Alan noted that the contributing factors organized by the different emphasis areas detailed in FDOT's Strategic Highway Safety Plan (SHSP) that were most associated with crashes involving teens were distracted driving, and speeding and aggressive driving.

Other key takeaways included that teens involved in fatal crashes were overwhelmingly male, crashes involving teens were occurring predominately in Florida's urban areas, teens involved in crashes were overwhelmingly occurring among teens driving passenger cars or vans, and that teens involved in crashes are overwhelmingly likely to be Florida residents as opposed to visitors.

Alan delved into motorcycle fatalities involving teens. He noted that within motorcycle fatalities, teens are disproportionately more likely to be in a fatal crash while riding a motorcycle. He emphasized that 1/3 teens that die in motorcycle crashes were not wearing a helmet, despite being required by law for all riders under the age of 18.

Participants had the following questions and comments:

- The coalition expressed interest in further data analysis on Marion County due to it being in the top 15 of total crashes involving teen drivers and its high proportion of alcohol related fatal crashes.
- Andre suggested including comparison lines for all drivers and inclusion of rates in addition to totals.
- Leah suggested comparing where teen drivers learned to drive and asked if that information is tracked.
 - This information is not tracked and is unlikely to be readily available.
- The coalition expressed interest in including data on restraint use in crashes involving teen drivers.
- The coalition expressed interest in comparing crashes involving teen drivers by Florida residency in key counties with high visitor populations.
- The coalition expressed interest in comparing teens involved in crashes while riding a motorcycle or moped within key counties where there is a high college student population.
- HB39 changes the requirements for how many hours teens are allowed to work and the time of day they are allowed to work. This could change this data over time if teens are allowed to work during these hours as it is the exception provided in Florida's GDL.
- Could we look at county of residence and see if drivers are from other counties and getting in crashes in different counties?
- Consider adding additional information about fatalities, serious injuries, and crashes and the types of roadway facilities they occur on.
- It would be interesting to see if teens involved in motorcycle crashes are overrepresented in college towns.

2023 Strategic Action Plan – Subcommittee Group Breakout Sessions

Melissa asked participants to divide into subcommittee groups and review their actions steps in the FTSDC Strategic Action Plan. Subcommittee groups worked collaboratively to report progress on action steps and identify next steps to accomplish prior to the

MEETING NOTES – AUGUST 28, 2024

Welcome and Day 1 Recap

Melissa welcomed participants back to Day 2 of the Florida Teen Safe Driving Coalition Meeting. She provided housekeeping updates, reviewed the activities from Day 1, the Day 2 agenda, and the meeting followed.

Florida Teen Safe Driving Coalition Awards

Melissa and presented the FTSDC awards to the following members:

Teen Motorcycle/Moped Crashes in Florida

Siwon Jang, Center for Urban Transportation Research (CUTR), presented on behavioral strategies to address motorcycle crashes. She said that motorcyclists are more vulnerable to fatal and serious injuries than motor vehicle occupants in traffic crashes, noting that according to NHTSA in 2022, fatal crashes involving motorcyclist occurred 22 times as frequently as fatal crashes involving motor vehicle occupants per vehicle miles traveled. Nationally, nearly 12 percent of fatal crashes involving motorcycles occurred in Florida. Additionally, in 2022 fatal crashes involving motorcycle riders made up nearly 18 percent of Florida's total fatal crashes, despite accounting for only 2 percent of Florida's overall traffic crashes.

Siwon then discussed motorcycle and moped crashes involving teen riders. She said that teens ages 15-19 were involved in 25 percent of fatal motorcycle crashes. Additionally, the number of fatal crashes involving teens and mopeds has increased since 2020. Geographically, over 48 percent of fatalities involving teens riding motorcycles occurred in Broward, Miami-Dade, Palm Beach, Hillsborough, Volusia, and Orange counties. Additionally, of the riders without required motorcycle endorsements that were involved in fatal crashes from 2017-2023, approximately 15-30 percent were teens ages 15-19. Siwon then analyzed fatal crashes by helmet usage and age with 40 percent teen motorcycle riders dying in fatal crashes from 2017-2023 without wearing their helmet, despite being required to by law. The number of fatal crashes involving teen motorcycle riders increases as teens age, supporting the idea that teens acquire false confidence as they age and drive or ride more. She also said that approximately 70 percent of fatal crashes involving motorcycle riders involved other vehicles.

Siwon concluded presenting by sharing the traffic safety resources and materials that Ride Smart Florida has developed to drive down fatalities and serious injuries.

Participants had the following questions and comments:

- John Bolen, Treasure Coast Driving School, asked if there was data that differentiated between three-wheel and twowheel motorcycles and if that data indicates that three wheel motorcycles are involved in less crashes.
 - Siwon said that its clear more riders are adopting three-wheeled motorcycles, there are online resources for three-wheeled motorcycle riders, and that the data exists. School sponsors are looking for more information about three-wheeled motorcycles, as well.
- Derek asked if the researchers looking at crash data ask why motorcycle registrations are increasing and suggested that it could be due to the increase in the cost of both new and used cars.
 - Siwon said that students could be choosing those motorcycles and mopeds because they are trying to save money.
- Art asked of the 30 percent of fatal crashes that involve just the motorcycle rider, how many involve drugs and/or alcohol?







- Megan said that Dr. Byers from the University of Miami (UM) gave a presentation to the Florida Impaired Driving Coalition (FIDC) that suggests a correlation between fatal single vehicle crashes and impairment.
- Megan asked if to receive a university parking pass, do motorcycle and moped riders need to be endorsed?
 - Rich said that to park a moped on the University of Florida's (UF) campus, students do not need a motorcycle endorsement.
- Janice asked if the teens riding motorcycles without a helmet are simply just breaking the law, since Florida statute requires motorcycle riders under the age of 2021 to wear an FDOT approved helmet.
 - Siwon said teens riding motorcycles without helmets often say they did not know a helmet was required since they see so many older riders without them. From an enforcement standpoint, it is challenging to identify teen motorcycle riders because the specialty plate may be too small to be easily visible.
- Mike Zinn, FDOT District 7, said that NHTSA offers grants for SMART Rider programs and suggested the numbers could be decreasing in those areas where there are SMART Rider programs.
 - Janice said only six agencies throughout Florida are receiving funding and participating in that program and asked if teens are going to those training programs.
 - Siwon said of the SMART Rider courses she has attended she had not seen teens present and that these programs are intended for experienced or newer adult riders.
- Corey Griffin, Florida Sheriff's Association, asked if the data includes All Terrain Vehicles (ATV) which are more commonly referred to as four-wheelers.
- Keith said the training courses could be required on university campuses to receive a parking pass.
 - The courses are voluntary training courses and parking policy is determined by each individual university.
- Derek asked where does micromobility fit in the FTSDC?
 - Janice said that the Pedestrian and Bicycle Safety Coalition and the Motorcycle Safety Coalition work on micromobility because of the blurred lines between the two. Crashes involving teens utilizing micromobility devices is likely underreported since law enforcement and by extension the Florida Department of Highway Safety and Motor Vehicles (FLHSMV), would not be working with a crash report.
 - Jodie Lindsey-Benware, Shands Health (UF) said that trauma center should have that data because nurses can identify different factors involved. Over the past two years Shands Health has been in the process of extracting micromobility injury data and will make it available in the future.
 - Leilani Gruener, FLHSMV, said that the Pedestrian and Bicycle Safety Coalition's Policy subcommittee is working on identifying changes to the crash report form to gather more information on micromobility crashes. Additionally, the trauma and Emergency Medical Services (EMS) subcommittee on the same coalition is gathering hospital data which may be more effective for determining single vehicle micromobility crashes. The Pedestrian and Bicycle Safety Coalition has also developed model language related to micromobility.
